2. NCPC MANAGEMENT AND OPERATIONS:

National Cleaner Production Center Foundation (NCPC) aims to introduce and promote Cleaner Production (CP) techniques for pollution prevention at source along with integrated waste management targeting sustainable development and community prosperity. It was established by United Nations Industrial Development Organization (UNIDO) in 1999 with collaboration of United Nations Environment Programme (UNEP), United Nations Development Programme (UNDP), EPAs, Ministry of Climate Change (MOCC) and Ministry of Energy (Petroleum Division). It is registered as not-for-profit organization under Section 42 of the applicable Companies Ordinance, 1984 (repealed by the Companies Act, 2017) and is certified by Pakistan Centre for Philanthropy (PCP) and Federal Board of Revenue (FBR). Cleaner Production provides an integrated preventive environmental strategy to processes and products in order to reduce risks to human and the environment. Through the CP program, NCPC is bridging the gap between competitive industrial production and environmental concerns.

NCPC has established global linkages particularly with RECPnet (UNEP and UNIDO global network), China NCPC and other international organizations through meetings, training programs and other events.

The company is carrying out broad categories of Environmental, Analytical, Energy, Waste Management Services (incineration, bioremediation and compositing), Capacity Building and Philanthropy Activities. Different Eco Model Projects regarding environment like Eco Model Villages, Societies, Oilfields, Universities, Colleges, Schools, Madrassas, Churches, Mandirs, Hospitals, Streets, and Parks have been initiated.

The Company has expertise in providing quality services in the following areas:

a) ANALYTICAL SERVICES

Monitoring of stack emissions, waste and drinking water, ambient air, vehicular emissions, noise emissions and petroleum products analysis provided to multi sector organizations and industries by NCPC environmental laboratory, Attock Refinery Limited quality control laboratory and other certified laboratories like PINSTEC, PCRWR, PCSIR, Green Crescent, ESPAK and Target Lab.

b) WASTE MANAGEMENT SERVICES

The incinerators having capacity of 150 kg/hr to incinerate hospital, pharmaceutical and industrial waste are fully operational. The community as well as industry is being benefited through this facility.

The hazardous waste management services have been provided to various hospitals, labs and clinics, power plants, petroleum and gas sector, multinational Non-Governmental Organizations, food and pharmaceutical industries.

c) ENVIRONMENTAL SERVICES

Environmental Impact Assessment (EIA), Initial Environmental Examination (IEE), Energy Conservation Audits, Hydrological Studies, Environmental and Social Monitoring, Trainings etc. under the category of Environmental Services have been provided to various sectors.

3. CORPORATE SOCIAL RESPONSIBILITY:

a. CAPACITY BUILDING

Training sessions and Internship opportunity has been provided to the students and fresh graduates for their capacity building through eco internship program. Internship experience covers field activities i.e. Surveys, Risk Assessment, Environmental Studies, Life Cycle Assessment (LCAs), Biodiversity Conservation, Environmental Monitoring, Environmental awareness campaigns in different segments of society like universities, colleges, schools, mosques, madrassa, mandirs, churches, NGO's, orphanages, old age homes, transgender community etc. and office-based activities i.e. administration, information technology and research for development.

Internship opportunities have been provided to the wide range of students from the top leading universities of Pakistan.

b. PHILANTHROPY AND COMMUNITY DEVELOPMENT ACTIVITIES

Philanthropy and Community Development activities performed during the year 2024-2025 are tabulated below:

1.	Pilot Projects in Universities of Pakistan	Pilot Projects Phase 8, a total of fourteen projects has been funded across leading universities of Pakistan, focusing on environmental sustainability, renewable energy and climate change mitigation. The projects span institutions such as Quaid-i-Azam University Islamabad, PMAS Arid Agriculture University Rawalpindi, University of Veterinary and Animal Sciences Lahore, Forman Christian College & University Lahore, University of Agriculture Faisalabad, University of the Punjab Lahore, Bahria University Karachi, Hamdard University Karachi, Federal Urdu University Karachi, Mehran University Jamshoro, BUITEMS Quetta, and AJ&K University Bhimber. The key themes include carbon capturing, bio-fuel and bio-plastic production, waste-to-energy conversion, avian and animal health monitoring and ground water vulnerability assessment. Innovative solutions such as biomass-derived electrodes, fungibased bio-fuels, biochar composites for waste water treatment and floating wet lands are being developed to tackle pollution and climate impacts. Marine and coastal resources are also explored through projects on seaweed utilization and shellfish by-product valorization. Additionally, forest resource conservation involves cultivating them outside their natural environment, like nurseries) and community participation in nursery development highlights the focus on biodiversity. Smart technologies such as IoT-based (Internet of Things) gas leakage detection systems and mobile health apps further expand the scope towards digital environmental management. Overall, these projects emphasize sustainable development, circular economy practices and scientific innovation to address pressing environmental challenges.
2.	Plantation Drive	Monsoon and spring tree plantation activities on ownership basis were performed at different educational centers like Schools, Colleges, Universities, Housing Colonies, Villages, Orphanages, Industries, Grid Stations, NGOs, Government and Private sectors of society. More than eighteen thousand trees have been planted.
